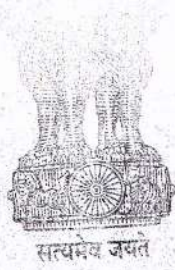

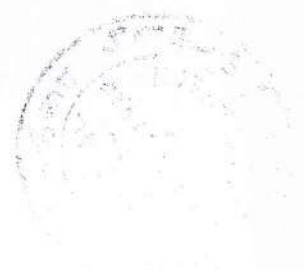
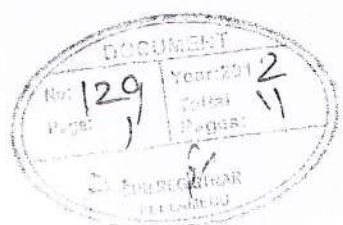

The Author of the Trust hereby appoints the following persons as trustees of the Trust

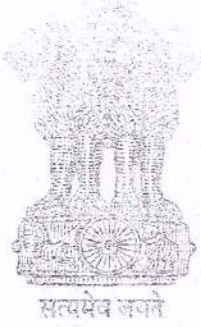

If any trustee dies, the children among his/her male and female descendants shall take his/her place. If any trustees decides to resign the office, he/she shall have the option of nominating

the children male and female descendant as the trustee in his/her place. If no nomination is made by the retiring trustee, the remaining trustees shall have the power of co-opting any person subject to the approval by the others, as a trustee in the place of outgoing trustees.

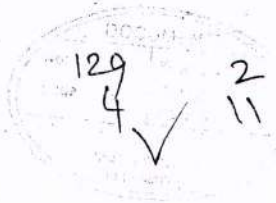
While considering the nomination of the trustee in the event of the death of the trustee the nominated person shall be a person competent to enter into contract as said in Indian Contract Act. In the event of any in-competency of the person nominated by the deceased trustee, this spouse of the deceased trustee shall be considered for appointment as trustee.

5.Object of the Trust

The trust has been formed for the object hereinafter mentioned which shall be available for all persons and institutions in India irrespective of caste, community, religion, sex, or nationality.

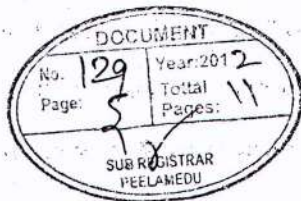
- a) To establish, maintain, run, develop, extend, grant donation for and to aid and assist in the establishment, extension of educational institutions, scientific, library, technical, industrial and otherwise including schools, colleges, polytechnics and research and institutes, workshops, etc., hostels for the benefit of students and working women and grant scholarships for the study, research and apprenticeship for all and any of the said purposes.
- b) To establish, maintain, run, develop, improve, extend, grant donations for and to aid and assist in the establishment, maintenance, running, development, improvement, and extension of hospitals, clinics, dispensaries, maternity homes and similar institutions affording treatment by way of alleviation of the sufferings of the humanity.
- c) To establish, maintain, run, develop, extend, grant donations for and to aid in the establishment, maintenance, running, development, improvement and extensions of paintings, and other works of art, recreation centers and other facilities, which are calculated to be of use in imparting education to the public.
- d) To build, erect and construct and to aid and assist in the building, erection and construction of houses, community halls, and places of residence for the poor, needy and handicapped and afford them all comforts and amenities.
- e) To conduct poor feeding and to give food, clothing, medicines and cash grants to the poor, needy and handicapped and to afford relief to people in distress and affected by earthquake, flood, famine, pestilence and other causes and to grant donations for the support of the inmates of orphanages, rescue houses, homes for aged persons and similar institutions and societies.
- f) To give donation to any institution or fund approved by or seeking approval of the Income-Tax Act-1961 with objects similar to this trust.

- g) To build, erect and construct and to aid and assist in the construction of poor homes, Marriage halls and community centers and permit all sections of the public to use the same freely subject to payment of incidental and maintenance charges only.
- h) To conduct all kinds of camps including awareness of Social Development, Women Development, Health, Education, Child Labour, Handicaps, Environment, Legal aid, AIDs, HIV, Mother & Child care etc.,
- i) To establish, administer, manage and maintain schools for welfare of civil society, which have been oppressed by poverty.
- j) To work for the welfare of rural women and children.
- k) To promote rural and urban youths skilled development courses/programs.
- l) To provide various trainings for rural people, small and deserving NGO's and youths.
- m) To organize camps, workshops, seminars on the matters and issues connected with rural development.
- n) To make the people to participate in our country's welfare.
- o) Formation of Health education centers, non-formal education centers and social education centers to bring social changes.
- p) To promote rural and urban health and education.
- q) To create the way for self improvement schemes for village people.
- r) To make the benefits of Government welfare schemes to the rural people.
- s) To enforce the need for clean environment and social forestry programme.
- t) To eradicate the untouchability without violence.
- u) To take dealership, tender, quota and agency for the development of this Trust.
- v) To protect our earth's atmosphere, ground water, organic-inorganic nature and ozone layer for human life resources.
- w) To promote cultural activities that will serve to enrich the lives of the people.

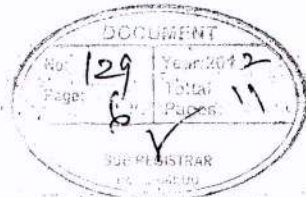

- x) To Provide relief to the needy in areas affected by natural calamities and other emergencies.
- y) To raise funds through grants, donations, loans, advances from sources such as Government sectors, semi- government sectors, private donors, well-wishers, banks, foreign donors agencies etc., for the fulfillment of the above objectives of the Trust.
- z) To take over or to merge with any Trust or Societies or Other Institutions with its assets and liabilities whether the objects are identical or not.
- aa) To carry out and to engage in any business activities as a measure to attain the objects of the Trust. However such business activities shall be carried out subject to the provisions of the Income tax Act.

Powers of the Trustees:

- a) The Board of Trustees shall from time to time frame the Regulations and Rules for the working of Trust. These Regulations can be amended only if at least two Trustees give their approval for such amendment. Before making any amendment, the trustees shall obtain the permission of Commissioner of Income Tax for such amendment.
- b) The Trustees shall meet at least once in three months. The minutes of the meetings shall be recorded in a minutes book by the Managing Trustee and the minutes shall be passed in the next meeting of the Trust, in token whereof, the trustees shall affix their signatures in the Minutes book at the appropriate place.
- c) The Managing Trustee of the Trust shall convene a meeting of the Trust if any two trustees give a notice in writing at least 7 days prior to the date on which they want the meeting to be conducted.
- d) The Quorum for any meeting of the Trust shall be two. The Managing Trustee of the Trust shall preside over all meetings of the Trust. In the case of any voting on any subject, if there us an equality of votes, the Managing Trustees shall have a casting vote.
- e) If any one of the Trustees are found to act in any manner prejudicial to the object of the Trust and if any financial indiscipline is proved against the Trustee, then the remaining trustees shall remove the said trustee from the board by a resolution passed with absolute majority of the board.
- f) The trustees shall have power to accept contributions in money or property, by way of donations, gifts, grants, subscriptions, aids from any private or public trust, institutions, government authorities, companies, firms, individuals or any other persons in India or outside India to the Trust funds generally or for any one or more of the specific objects of the Trust. Such contributions shall be dealt with either as corpus or as income according to the directions of the donors and acceptance of the trustees at the time of the contribution.

- v) Any amendment to the Trust deed shall be carried out only with prior approval of the Commissioner of the Income Tax.
- vi) The benefits of the Trust are open to all, irrespective of caste, creed, religion, sex, etc.,
- vii) The object of the Trust shall be carried out only in India. The income and funds of the Trust will solely be utilized towards the object of the Trust and no portion of it will be utilized for payment to the trustees/office bearers by way of profit/dividend/ interest, etc.,
- viii) As a measure to attain the object of the Trust the Trust is empowered to do business, the business includes purchases and sale of goods and merchandise either as a whole sale or as a retailer. Also to do business as importers and exporters of goods and merchandise and also exporters of services. In the event of doing such business, it shall be done by complying with the conditions stipulated in sec 11(4) and proviso to sec 80G (5)(i) of the I.T. Act.
- ix) The accounts of the Trust shall be regularly maintained and every year the accounts shall be closed by 31<sup>st</sup> march and the same shall be audited by a qualified Chartered Accountant.
- x) The Trust does not own any immovable property at present.
- xi) For the clauses which are not explicitly defined in the deed of Trust the provisions of the Indian Trust Act shall apply.

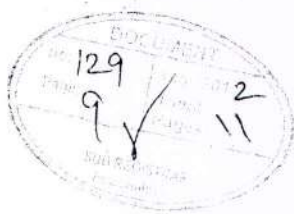
